As noted last year we continue to work towards the sale of a portion of the clubs land for the purpose of a Residential Aged Care Facility for the benefit of the community and the club. These negotiations are ongoing and take time to get the right result.

I must thank the members that attended our General Meeting that has seen the clubs Audit team change this year that we believe will result in improved reporting for the benefit of the club and its members. As noted to those at the meeting the club continues to improve its practices and its trading results in what continues to be difficult times for many in the industry.

These improvements come from a commitment to see your club improve and are bourne from the efforts of your directors, who have all undertaken and completed the required mandatory training for Club Directors over the last twelve months leading to a greater understanding of the board's role and responsibilities. I would also like to acknowledge the retirement of Stewart Bills from the board earlier this year as he moves to the north coast and welcome Rob Brownlow to the board.

With elections being held this year I would encourage all members to cast your vote and have your say as the stronger we are together the stronger Toongabbie Sports Club will be.

This year alone members have enjoyed more than \$370,000 in member benefits and promotion prizes and that's even before you consider the price savings across the bar.

In terms of Community Support the club contributed more than \$160,000 back to various local community groups to the direct benefit of the Toongabbie Community and our members.

It is important to remember that Community Support is a part of the DNA of clubs and when you visit your local club you are INVESTING IN YOUR COMMUNITIES FUTURE.

To those that have lost friends, family and loved ones my condolences.

In closing I must, as always, thank our tireless volunteers, committee members and our dedicated staff who strive to service your needs each and every time you visit.

TREASURER'S REPORT

As noted by the Chairman the club undertook an external audit of the clubs accounts and practices early this year to ensure compliance and best practice.

While the investment was not a "cheap" exercise it certainly proved to be "valuable" with the audit identifying several ongoing deficiencies in the clubs reporting.

The issues identified seem to be predominantly a case of "it's the way we have always done it.", rather than something intentional – regardless the matters are now addressed including a restatement of the clubs 2014 accounts that clearly identify the new standards and the impact on the clubs stated trading position.

So to the year at hand, the club can report a profit of \$256,813, up significantly on last year, achieved predominantly through increased sales with overall F. club revenue increasing by 14% to \$4.2M (2014 \$3.7M) with solid growth in all core trading areas. It must be noted that this year's increases come off the back of last year's 19% growth.

Despite increasing revenue, cost control also improved seeing a reduction of \$231,420 (-5%) in expenses.

While we have secured modest finances out until December 2017 the clubs total liabilities fell by \$414,015 (-32%).

As a club we are clearly now looking to the future and seek to not only maintain the current results but continue our growth, with a firm view to securing the future of Toongabbie Sports Club. While I believe we are on track, the fact that our lender has now returned the deeds to the clubs property speaks independently to the clubs more recent performance.
